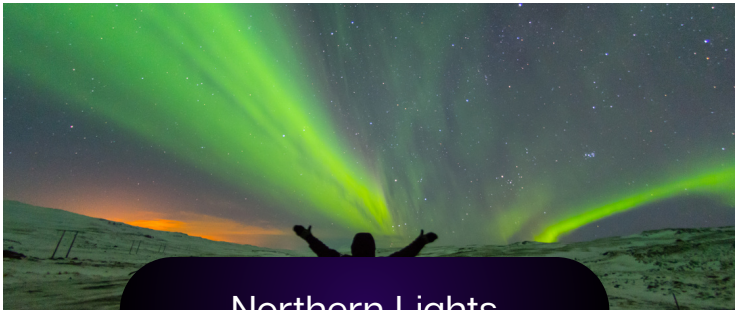

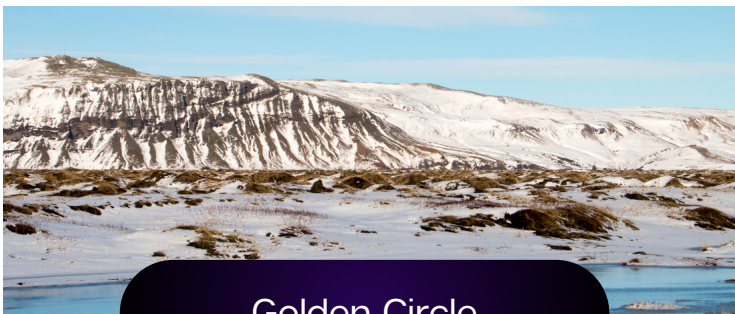

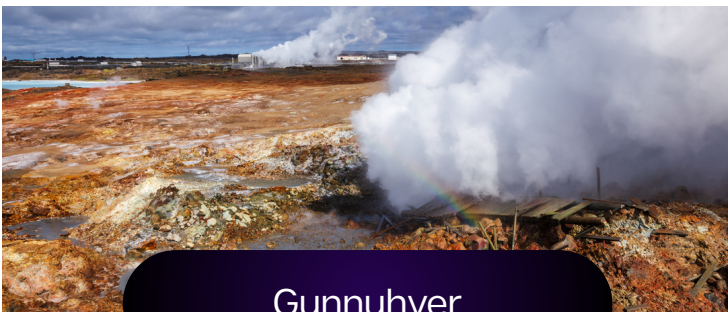
Northern Lights

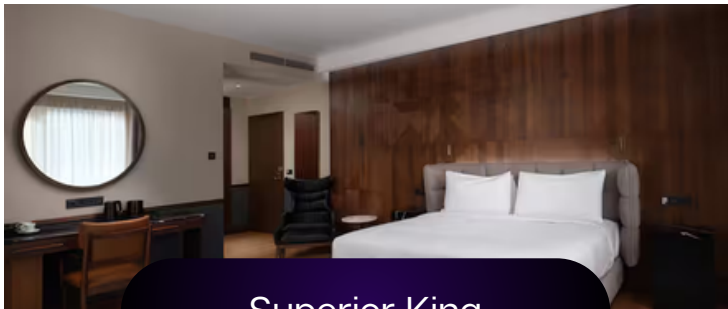

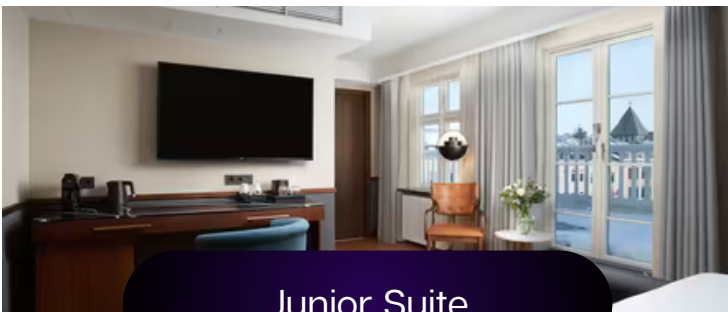

On this adventure, you'll hunt for the Northern Lights (there is no guarantee that you will see the Northern Lights, but we will make our best efforts to try), enjoy traditional Icelandic cuisine, and explore the landscapes that have named this island the land of fire and ice. Tour Provider: EPIX Travels. Group Limit: The tour is capped at 18 participants. Flight Information: EPIX Travels disclaims any responsibility for cancellation fees related to non-refundable airfare booked in connection with this tour. The airline ticket itself will be the only agreement between the traveler and the airline.
